## Credit transfer Scheme for Students from other Universities

Under this scheme Students from other UGC recognized Universities can seek transfer to SMU-DE.

- This scheme is applicable for both UG and PG Programs as mentioned in Table 1.
- Program based transfer only is permitted (Title of the program should match)
- Students who have successfully completed 1<sup>st</sup> or 2<sup>nd</sup> year or 1 to 3 semesters in the previous University are eligible.
- Students with backlog papers in 1<sup>st</sup> or 2<sup>nd</sup> year or 1 to 3 semesters are **NOT ELIGIBLE**.
- Students are required to complete at least 50% of program duration with SMU-DE.
   Eg 1. If a UG student seeks Credit Transfer after 1<sup>st</sup> year, can seek admission to 3<sup>rd</sup> Semester.
  - Eg 2. If a UG student seeks Credit Transfer after  $2^{nd}$  year, can seek admission to  $4^{th}$  Semester.
- Credit transfer is permitted for only such students who are currently in the system.
   i.e., those whose validity is still in vogue (as per SMU norms)
- Students seeking admission through Credit transfer are required to submit Migration Certificate from the previous University and additional application form for credit transfer. (with undertaking letter as per the format)
- Medium of instruction is **English**. Hindi medium is available for select programs.
- Students shall pay a Credit Transfer fee at the time of enrolment.
